## "AF/ARMAFLEX"

Insulating material for piping\* made up of closed-cell elastomeric foam based on synthetic rubber. Glued to pipes (Armaflex adhesive, maximum application rate as per test) or self-adhesive.

Black color - Tested glued on 1 mm steel sheet.

Density: approx. 45-65 kg/m<sup>3</sup>

Single or multi layers application - Maximal thickness: 50 mm

## **4. APPLICATION / LIMITATION:**

- 4.1 In application of FTP Code 2010 Annex 2 § 2.2, the product is expected to satisfy the requirement of smoke & toxicity without further testing.
- 4.2 In application of FTP Code 2010 Annex 2 § 2.3, the product is expected to satisfy the requirement of maximum gross calorific value (e.g.  $45 \text{ MJ/m}^2$ ) without further testing.
- 4.3 Approved for use as insulation of pipes fittings for refrigeration systems and chilled water piping for air-conditioning.
- 4.4 The fitting aboard to be the same as used for the test.
