1. Purpose

- 1.1 These Portal Terms of Use apply to each use of the Portal.
- 1.2 To access the Portal and use the subscription remote service ("Remote Service") provided by Flamco, you must make use of the username and password provided to you for that purpose. You are responsible for keeping all log-in data confidential and secure and will follow all reasonable instructions in that respect required by Flamco.
- 1.3 Flamco at its sole discretion may change the Portal (such as adding, amending or deleting functionalities, amending look and feel) and these Portal Terms of Use. Your continued use of the Portal post any modifications undertaken by Flamco to the Portal Terms of Use shall be construed as your acceptance to the modifications. It is your responsibility to check these Portal Terms of Use when you use the Portal to take notice of any changes Flamco makes, as they are legally binding on you. 2. Prohibited Uses

- 10.2.6 disclosure of such information to law enforcement authorities as we reasonably feel is necessary.
